Part A: Pupil premium strategy plan

Statement of intent

When making decisions about using Pupil Premium funding it is important to consider the context of the school and the subsequent challenges faced. This alongside research conducted by the EEF. Common barriers to learning for disadvantaged children can be: less support at home, weak language and communication skills, lack of confidence, more frequent behaviour difficulties and attendance and punctuality issues. There may also be complex family situations that prevent children from flourishing. The challenges are varied and there is no "one size fits all".

We will ensure that all teaching staff are involved in the analysis of data and identification of pupils, so that they are fully aware of strengths and weaknesses across the school.

At Gwladys Street Community Primary and Nursery School, we target the use of Pupil Premium Grant funding to ensure that our disadvantaged pupils receive the highest quality of education to enable them to become active, resilient and socially responsible citizens of the future. We recognise that disadvantaged children can face a wide range of barriers which may impact on their learning.

Our ultimate objectives are to:

- Remove barriers to learning created by poverty, family circumstance and background
- Narrow the attainment gaps between disadvantaged pupils and their nondisadvantaged counterparts both within school and nationally
- Ensure ALL pupils are able to read fluently and with good understanding to enable them to access the breadth of the curriculum
- Develop confidence in their ability to communicate effectively in a wide range of contexts
- Enable pupils to look after their social and emotional wellbeing and to develop resilience.
- Access a wide range of opportunities to develop their knowledge and understanding of the world

How we aim to achieve this;

- Provide all teachers with high quality CPD to ensure that pupils access effective quality first teaching
- We will ensure that effective teaching, learning and assessment meets the needs of all pupils through the rigorous analysis of data.
- Class teachers will identify through the class pupil premium plan specific measurable intervention and support for individual pupils which will be reviewed at least termly.
- Provide targeted intervention and support to quickly address identified gaps in learning including the use of small group work, 1:1 tuition
- Employ additional teaching staff to allow 'Catch up' teaching to take place in identified year groups.

- Alongside academic support, we will ensure that those pupils who have social, emotional and mental health needs will access high quality provision from appropriately trained adults.
- Provide opportunities for all pupils to participate in enrichment activities including sport and music
- Provide appropriate nurture support through Calm Central to enable pupils to access learning within and beyond the classroom.
- Providing the wider community with training, access to agencies and support

In making provision for socially disadvantaged pupils, we recognise that not all pupils who receive free school meals will be socially disadvantaged. We also recognise that not all pupils who are socially disadvantaged are registered or qualify for free school meals. We reserve the right to allocate the Pupil Premium funding to support any pupil or groups of pupils the school has legitimately identified as being socially disadvantaged.

Demography and School Context

Gwladys Street is a large, friendly, two form entry primary school with capacity for 102 pupils in our Nursery. The school is steeped in history and generations of families and children have continued to attend since the school first opened its doors 1912.

Gwladys Street Community Primary and Nursery School is located in the Walton area of Liverpool within the County ward.

Based on the deprivation indicator, Liverpool is ranked one of the highest levels of most socially deprived areas within the country (2019) With Liverpool considered the 4th most deprived local authority in England (previously ranked 7th in 2015)

For Average Score, Liverpool is considered the 3rd most deprived of 317 local authority areas. It was ranked as the 4th most deprived in 2015, having previously been ranked the most deprived in 2004, 2007 and 2010.

For Average Rank, Liverpool is considered the 4th most deprived local authority in England (previously ranked 7th in 2015).

For proportion of Lower-layer Super Output Areas (LSOAs) in the most deprived 10% nationally, Liverpool is ranked 2nd most deprived (previously ranked 4th).

145 of 298 LSOAs (49%) in Liverpool are in the most deprived 10% nationally. 48% of the city's residents, and 57% of its children, live in these LSOAs. 31 LSOAs are in the most deprived 1% in England.

Liverpool has one LSOA, located in Anfield electoral ward, in the top 10 most deprived LSOAs, and seven that are in the top 100 most deprived out of 32,844 in England. Of these, three are located in Anfield, two in Everton, one in County, and one in Tuebrook and Stoneycroft.

Liverpool City Region is ranked as the most deprived of England's 38 LEP areas.

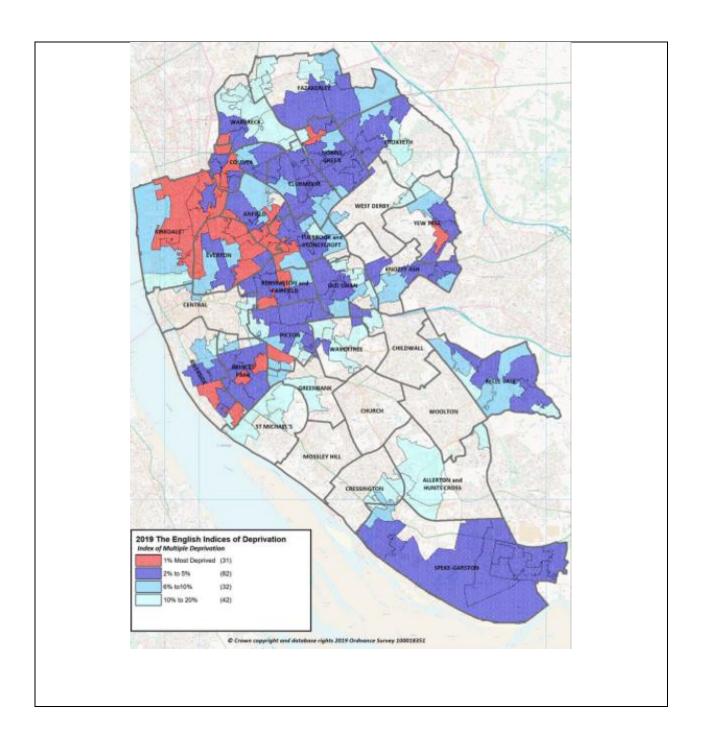

- 2. The teaching of phonics should be explicit and systematic to support children in making connections between the sound patterns they hear in words and the way that these words are written.
- 3. The teaching of phonics should be matched to children's current level of skill in terms of their phonemic awareness and their knowledge of letter sounds and patterns (graphemes).
- 4. Phonics improves the accuracy of the child's reading but not necessarily their comprehension. It is important that children are successful in making progress in all aspects of reading including comprehension, the development of vocabulary and spelling, which should also be taught explicitly.

Early literacy approaches typically increase children's learning by about four months. Approaches that develop literacy skills and knowledge can have an important effect on early reading. The evidence for the positive impact of early literacy approaches is extensive.

Early literacy interventions seem to have impacts that transfer to other areas of the curriculum such as mathematics, where the average impact is + two months progress.

Small Group Tuition +4 months progress

- 1. Small group tuition has an average impact of four months' additional progress over the course of a year.
- 2. Small group tuition is most likely to be effective if it is targeted at pupils' specific needs. Diagnostic assessment can be used to assess the best way to target support.
- 3. One to one tuition and small group tuition are both effective interventions. However, the cost effectiveness of teaching in small groups indicates that greater use of this approach may be worthwhile.
- 4. Providing training to the staff that deliver small group support is likely to increase impact.
- 5. Additional small group support can be effectively targeted at pupils from disadvantaged backgrounds, and should be considered as part of a school's pupil premium strategy.

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

Outcomes for the previous year can be located on the previous 3 year plan on the school website.

Review of 2024/25 Outcomes – Completed December 2025

Improve attendance and reduce persistent absentee rates:

A comparison of attendance figure for the same point of the year shows an overall increase for the whole school population. The level of persistent absence has also reduced by 1.13%.

Pupil Premium attendance has increase by 1.05% however PA's within Pupil Premium has increased by 1.56% and this will be a target for the new year to address this.

Overall, the picture has improved across school with attendance however there are still key vulnerable groups such as SEND and Persistent Absence within Pupil Premium children where progress is limited.

Improve attainment and progress in phonics

2024/25:

School Pass Rate = 51%

Whilst school acknowledge that school are significantly below the national average data, there are marked improvements on previous school data. This sits within the context of the significantly higher levels of SEND support and EHCP's compared to national average.

School continues to work closely with Read Write Inc and utilise whole staff training days and bespoke training where gaps and need has been identified. School have also invested in members of staff specifically trained in delivered Fresh Start and who are Fast Track Tutors to close the gap and support those children who did not pass the screening check in Year 1.

School also follow the spelling programme devised by Read Write Inc.

In the 2024/25 end of Key Stage 2 tests, we saw well above national levels of SEND and EHCP. 42% of the cohort had SEND with 15% of that cohort also holding an Education Health and care plan. This compares with the national average of 14.8% and 3.5% respectively.

There have been encouraging signs with our Phonics and Early Reading (See above data) and we hope that this filters through school having a positive impact on our outcomes with more children starting Key Stage 2 passing Phonics.

36% of Pupil Premium children achieved the expected standard in Reading.

13% of Pupil Premium achieved Greater Depth in Reading.

Literacy Counts continues to be embedded across school and alongside the use of Pixl Therapies, we hope this will have a positive impact on pupil attainment at the end of Key Stage 2.

Reading is taught throughout the curriculum, including Foundation Subjects where pupils use Opening Worlds to develop their fluency in reading.

36% of Pupil Premium children achieved the expected standard in Writing.

School have identified Maths as a Key area for this upcoming year and have introduced Pixl Assessment and Therapies as a tool to help close the gaps and ensure high attainment. This allows staff to deliver bespoke intervention, small group and whole class support for targeted and specific areas of the curriculum where gaps persist. These children are identified and monitored through Pupil Progress Meetings.

We continue to be part of the North West Maths Hub.

36% of Pupil Premium children achieved the expected standard in Maths.

Additional activity

Our pupil premium strategy will be supplemented by additional activity that is not being funded by pupil premium or recovery premium. That will include:

- embedding more effective practice around feedback. <u>EEF evidence</u> demonstrates this has significant benefits for pupils, particularly disadvantaged pupils.
- utilising a <u>DfE grant to train a senior mental health lead</u>. The training we have selected will focus on the training needs identified through the online tool: to develop our understanding of our pupils' needs, give pupils a voice in how we address wellbeing, and support more effective collaboration with parents.
- offering a wide range of high-quality extracurricular activities to boost wellbeing, behaviour, attendance, and aspiration. Activities will focus on building life skills such as confidence, resilience, and socialising. Disadvantaged pupils will be encouraged and supported to participate.

Planning, implementation, and evaluation

In planning our new pupil premium strategy, we evaluated why activity undertaken in previous years had not had the degree of impact that we had expected. We also commissioned a pupil premium review to get an external perspective.

We triangulated evidence from multiple sources of data including assessments, engagement in class book scrutiny, conversations with parents, students and teachers in order to identify the challenges faced by disadvantaged pupils. We also used the EEF's families of schools database to view the performance of disadvantaged pupils in schools similar to ours and contacted schools with high-performing disadvantaged pupils to learn from their approach.

We looked at a number of reports, studies and research papers about effective use of pupil premium, the impact of disadvantage on education outcomes and how to address challenges to learning presented by socio-economic disadvantage. We also looked at studies about the impact of the pandemic on disadvantaged pupils.

We used the <u>EEF's implementation guidance</u> to help us develop our strategy, particularly the 'explore' phase to help us diagnose specific pupil needs and work out which activities and approaches are likely to work in our school. We will continue to use it through the implementation of activities.

We have put a robust evaluation framework in place for the duration of our three-year approach and will adjust our plan over time to secure better outcomes for pupils.
